9	designs that we made public to the community
10	several months ago, and hopefully can start
11	construction in early end of spring, early
12	summer. Also, I would like to acknowledge Ms.
13	Devine for her assistance in getting an article
14	published on the awards received by the Police
15	Department. I wasn't able to do so at our
16	prior meeting, but I would like to acknowledge
17	her publicly for her assistance and support to
18	the Police Department in getting that
19	published. Also, Chief Robinson, I'd like to
20	make an announcement that we have received
21	another grant award for body armor for our
22	police officers. Chief Robinson, can you give
23	us more details?

2	procedures to internal control safeguard
3	(inaudible) during an investigation by SLED.
4	He testified under oath at the deposition that
5	I was a good chief, that I was never
6	reprimanded or anything like that, that the
7	only reason why he terminated me 'cause I was
8	arrested by the City of Conway and lost my
9	certification and could not perform my duties.
10	So he said they sent up all this extra stuff
11	on my PCS form. I spoke with Chief Keel of
12	SLED today. I spoke with the Academy today.
13	They both agreed that this needs to be changed
14	on my PCS form (inaudible) Council to call a
15	special call a meeting and put me on the
16	agenda. I sent up documents, but he said that
17	he wasn't going to give them to you all today
18	because it wasn't part of the agenda today for
19	you all to look over what I just read to you
20	all. So, I spoke with both of those, they
21	agreed that it needs to be changed, and I'm
22	hoping that Town Council will get together and
23	change (inaudible) 'cause I don't want to look
24	at any other options as filing another lawsuit
25	against the Town to make this happen. Also,
