All right ---15 16 MAYOR EVANS: Sounds good. 17 MR. KLEIN: _ _ _ look at the first page of the 18 budget, what I've done is you can see the first 19 two columns -- actually the preceding prior 20 year's actual numbers, right? 21 IN UNISON: Uh-huh. 22 So, column 1, fiscal year '21 to '22, MR. KLEIN: 23 column 2 is fiscal year '22 to '23, and then 24 the section in the middle that's blocked off is 25 gonna be our current year comparison to our

2	blocked off section, you'll see 2023-2024,
3	those were our budgeted numbers for this year.
4	And then the next column is our projected, and
5	so what that is, is a rolling 12 months, and so
6	I did this budget at the end of March yes,
7	March 31st so that would be April of '23
8	through March of '24, and that's gonna get our
9	projected numbers for this year. And then you
10	can see the column immediately to the right is
11	our variance so where we thought we would be to
12	date and then where we are, and then the next
13	column is the variance from budget, right? And
14	so, obviously and some of the areas of the
15	variance are larger, probably some of the areas
16	we're going to look at, right, when we think
17	about the coming year budget. And then the
18	final column on the right is a budget again,
19	it's a preliminary budget and it's just based
20	off of our current projections, right? So when
21	we think about next year, we're thinking about,
22	well, we think it's gonna be like this year
23	that's our starting point and then we're
24	going to, you know, make some changes, right?
25	That's I think the purpose of our meeting

2	I go on, any questions or anything I need to
3	address before we go into some more details?
4	MAYOR EVANS: You got questions, guys?

8	MAYOR EVANS: Uh-huh.
9	MR. KLEIN: Well, the areas that I starred I know
10	the stars are kind of small, but I starred a
11	couple areas on this projection going forward.
12	And that first star is payroll, or personnel
13	cost, the second one is gonna be professional
14	services but that's primarily legal fees, and
15	then the third starred item there is gonna be
16	our capital purchases, right? And if you look
17	at those, those are probably gonna be areas I
18	think of concern, or areas that need to be
19	addressed going forward to next year.
20	MAYOR EVANS: Go through those again for me.
21	MR. KLEIN: Yeah, so the starred items, we see
22	personnel costs, that would be the top star
23	MAYOR EVANS: Right, uh-huh.
24	MR. KLEIN: The next one is professional services,
25	and that's see on the detail page, on the

2	fees. And then capital purchases is gonna be
3	the next one so
4	MAYOR EVANS: Gotcha.
5	MR. KLEIN: when we turn to page 2, those are
6	broken down into detail, and I guess the final
7	point we would want to make here as we start
8	thinking about changes to the budget, obviously
9	these preliminary numbers are showing a
10	deficit, right, at the bottom, and we need to
11	pass a balanced budget so obviously, we're
12	gonna need to take a closer look at some of our
13	budgetary expenditures. And so those are at
14	least the highlighted ones, they're some of the
15	larger ones, and then also I think the capital
16	purchases, I started that one because there
17	were no budget there was not in the budget
18	for this coming year and yet, as we see in the
19	next page, you know, there's been expenditures
20	made to that
21	COUNCILWOMAN GORE: Right.
22	MR. KLEIN: so Okay. So, page 2 is where
23	I've broken out those three starred items so
24	it's basically just a detail.
25	MAYOR EVANS: Okay.

2	and I've basically blown up, or broken out,	
3	those personnel costs and details. So, out of	
4	the \$786,000 that were projected for next year	
5	for total personnel costs, you can see the	
6	breakdown here on page 2, right? And what I've	
7	done here on page 2, the reason why it's more	
8	expense or I guess the costs are higher than	
9	projected, we projected this year to be 650 but	
10	a few weeks ago when talking with the prior	
11	Town Manager, some of this information is from	
12	him, he had mentioned that we were going to be	
13	adding a new Town Administrator to payroll and	
14	so his the prior Administrator, he was a	
15	contractor, and so his costs were being taken	
16	from another line item and so we were just	
17	shifting funds, right, from one item one	
18	line item to another. And he had also	
19	mentioned potentially hiring an assistant and	
20	so I'm so the numbers I have there are based	
21	off of numbers that Mr. Quattlebaum gave me.	
22	And so, any questions on that, the personnel	
23	costs?	
24	(Inaudible background discussion.)	
25	MAYOR EVANS: So, he's got that included in the

3	way down, you can see there's two stars about

15	MAYOR EVANS: Okay.
16	MAYOR PRO TEM ISOM: Okay.
17	MR. KLEIN: So essentially, we're taking one
18	expenditure and we're moving it
19	MAYOR EVANS: Right.
20	MR. KLEIN: to payroll and then also potentially
21	adding another employee
22	MR. BELLAMY: So the \$574,000 number is based on
23	adding another employee?
24	MR. KLEIN: That's correct. Actually, adding two
25	employees. And so it would be the Town

8	and so our goal would be not just to break even
9	but it would be to break even with a
10	contingency item 'cause they're gonna happen,
11	right?

18	break-even budget and it would give you a

20	trying to make up the deficit of about \$77,000.
21	Would it be nice to add back about \$100,000
22	MAYOR PRO TEM ISOM: Uh-huh.
23	MR. KLEIN: just out of a little bit of room for
24	unexpected things 'cause they always happen.
25	MR. BELLAMY: Right, okay.

23	item but it was not at all used.
24	COUNCILWOMAN GORE: Oh.
25	MAYOR PRO TEM ISOM: Okay.

16	MR. KLEIN: And we made up that deficit.
17	MAYOR EVANS: Okay.
18	(Inaudible background discussion.)

20	for Mr. Klein?

23	workshop. If we can find a way to change the
24	legal we just don't have we don't have
25	the legal cost in the budget
