II. **Ordinance No. 4-2026** – An Ordinance Establishing Sexually Oriented Business Licensing Requirements and Regulations within Atlantic Beach — ***First Reading***

Whereas sexually oriented businesses require special supervision from the Town's public safety agencies in order to protect and preserve the health, safety, and welfare of the patrons of SOB businesses and the Town's citizens.

III. **Resolution No. 1-2026** – A Resolution of the Town Council of the Town of Atlantic Beach censuring Mayor Pro Tem John W. David, Jr. for violation of the Council-Manager Form of Government.
