Ordinance No.13-2025** – Amendment to Ordinance No. 1-2022 Business License Ordinance Section 10. Inspection and Audits including Life Safety Inspection – **Second Reading.** An ordinance to amend Ordinance No. 1-2022, Business License Ordinance, Section 10, Inspection and Audit, to include provisions requiring Life Safety Inspections for businesses operating within the Town.
