WHEREAS, the Town of Atlantic Beach (hereinafter "the Town") is committed to supporting community events that foster economic development, cultural enrichment, and public engagement within the Town; and

WHEREAS, Bikefest 2026 is a significant community and tourism event anticipated to attract a substantial number of visitors and participants to the Town, generating economic activity and promoting the Town's local businesses and public image; and

WHEREAS, the successful execution of Bikefest 2026 requires the procurement of entertainment services, including but not limited to live musical performances, stage productions, performing artists, and related entertainment programming, through formal Entertainment Vendor; and

WHEREAS, a certain Entertainment Vendor Agreement entered into in connection with Bikefest 2026 are expected to exceed Five Thousand Dollars (\$5,000.00), thereby requiring formal authorization pursuant to the Town's procurement policies and applicable law; and

WHEREAS, the Interim Town Manager has identified the need to act in a timely manner to secure qualified entertainment vendor necessary for the planning and execution of Bikefest 2026, and the Town Council finds it to be in the best interest of the Town to grant such authorization; and

WHEREAS, the Town Council finds that authorizing the Interim Town Manager to enter into Bikefest 2026 Entertainment Vendor Agreement serves the public interest and advances the Town's goals of community engagement and economic development;

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Atlantic Beach, as follows:

Section 1. Authorization. The Interim Town Manager is hereby authorized to negotiate, execute, and enter into Bikefest 2026 Entertainment Vendor Agreement on behalf of the Town of Atlantic Beach, including that exceed Five Thousand Dollars (\$5,000.00), subject to the conditions set forth herein.

Section 2. Scope of Authorization. This authorization shall apply to Entertainment Vendor for services related to Bikefest 2026, including but not limited to: (a) live musical acts and performing artists; (b) stage and production management services; (c) sound, lighting, and audio-visual production; (d) entertainment coordination and booking services; and (e) any other entertainment-related vendor services necessary for the successful execution of Bikefest 2026.

Section 3. Conditions of Authorization. The Entertainment Vendor Agreement entered into pursuant to this Resolution shall: (a) be consistent with the Town's procurement policies and all applicable state and local laws; (b) be within the limits of appropriated and available funds in the Town's adopted budget; (c) be reviewed and approved as to form by the Town Attorney prior to execution; (d) include appropriate indemnification, insurance, and liability provisions to protect

the Town; and (e) be reported to the Town Council at the next regularly scheduled Council meeting following execution.

Section 4. Insurance Requirements. The Interim Town Manager shall ensure that all entertainment vendors executing pursuant to this Resolution maintain adequate general liability insurance, naming the Town of Atlantic Beach as an additional insured, in amounts consistent with the Town's standard contract requirements and as otherwise deemed appropriate given the nature and scope of services to be provided.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption by the Town Council.

Section 6. Severability. If any section, clause, or provision of this Resolution is found to be unconstitutional or invalid, such finding shall not affect the remaining provisions of this Resolution, which shall remain in full force and effect.

PASSED, ADOPTED, AND APPROVED by the Town Council of the Town of Atlantic Beach at a duly noticed public meeting held on the 4th day of May, 2026.
